Chapter I – General Provisions

- These rules apply to all leagues and tournaments organized by Rugue Ideas Sport Eventos.
- Referees' decisions during matches are final.
- Administrative and disciplinary decisions are determined exclusively by Rugue Ideas Sport Eventos.
- Rugue Ideas Sport Eventos reserves the right to modify these rules for safety, fairness, organization, or facility compliance.

Chapter II – Game Formats & Fields

- Small Field (East Coast / Solaris): 2017–2020 divisions play 7v7 (including goalkeeper).
- After 2017 divisions may play 6v6 (including goalkeeper).
- Large Field: 8v8 (including goalkeeper). DAC format is exclusively 8v8.
- Maximum roster size per team: 14 players.

Chapter III – Match Duration

- All matches consist of two (2) halves of twenty (20) minutes each.
- Running clock format.
- Halftime break determined by the organization based on the schedule.

Chapter IV – Registration & Roster

- Maximum of 14 registered players per team.
- All players must complete the required waiver before participation.
- Player registration is allowed only through Match Day 3 of the season/tournament.
- No new registrations will be accepted after the third match day.
- If the head coach is absent, the assistant coach assumes responsibility. If neither is present, notification must be provided in advance.

Chapter V – Uniform

- All players must wear the official team jersey with a visible number on the back.
- All players must wear matching team jerseys.

- Shorts must match the official team color.
- Socks should preferably match (optional).
- Players without the complete official uniform may not participate.

Chapter VI – Minimum Players

- 7v7 → Minimum 4 players (including goalkeeper).
- 6v6 → Minimum 4 players (including goalkeeper).
- 8v8 → Minimum 5 players (including goalkeeper).
- If a team does not meet the minimum at kickoff, the match will be declared a forfeit.

Chapter VII – Player Restrictions

- Teams may not use players registered to another team to complete a roster.
- If a player participates for two different teams, the team automatically forfeits the match.
- The player will receive a two (2) match suspension.
- All players must be officially listed on the team roster.

Chapter VIII – Special Participation

- A girl may participate in a younger age division than her age group.
- Maximum allowed under this exception: one (1) player per team.
- Participation requires organizational approval.

Chapter IX – Safety & Discipline

- Shin guards are mandatory.
- Metal studs are not permitted in indoor facilities (East Coast & DAC).
- Jewelry is not permitted during play.
- Slide tackles are prohibited.
- Dangerous or reckless contact is prohibited.
- Yellow Card: Warning.
- Second Yellow (same match): Automatic send-off. Player may return next match.

- Direct Red Card: Immediate send-off and automatic one (1) match suspension.
- Rugue Ideas Sport Eventos may increase suspensions for serious incidents.
- Each team is responsible for the conduct of its players and spectators.

Chapter X – Points System

- Win: 3 points.
- Draw: 1 point.
- Loss: 0 points.

Chapter XI – Tiebreakers

- 1. Goal difference.
- 2. Goals scored.
- 3. Goals conceded.

Chapter XII – Forfeits & Protests

- If a team does not meet the minimum number of players at kickoff, the match is declared a forfeit.
- Protests must be submitted the same day at the Registration Table.
- Referee decisions on the field of play are not protestable.

Chapter XIII – Facility Rules

- All participants must respect facility rules.
- Each team is responsible for maintaining cleanliness of their area.
- Matches will begin and end on time to maintain the event schedule.
